Special Conditions (requirements for the supplier, payment terms, delivery terms, availability of permits, etc.)

1.Terms and Conditions

The Supplier – within the scope of supply, must ensure and perform the following tasks: conduct an analysis of the current position of the Republic of Uzbekistan in international

AI rankings;

provide recommendations for optimizing the country's position;

carry out work to optimize the country's position in international AI rankings.

The Supplier undertakes to commence work for the provision of services to optimize the position of the Republic of Uzbekistan in international rankings on artificial intelligence no later than 5 business days from the date payment is credited to its bank account.

2. Special Conditions – provided in this section take precedence over other contract terms

To participate in the selection process, the following documents must be provided:

- Certificate of registration of the legal entity Participant;
- Copies of permits and licenses for the enterprise's activities;
- Power of attorney for the contact person from the Participant.

3. Additional Mandatory Requirements for Participants:

- The selection Participant must be a company with experience in analyzing countries for AI readiness;
- Experience in providing similar services for at least 3 years;
- Warranty of at least 1 year;
- Possession of relevant licenses to conduct activities.

4. Composition and List of Price Proposal Documents

The Participant must submit a price proposal along with the competition proposal.

The Customer has the right to reject any price proposal that does not fully comply with the requirements for the preparation of Competition documents or to set conditions for further consideration of the competition proposal, notifying the Participant accordingly (the price proposal is not the predominant factor for selecting the Participant).

5. Procurement Terms and Detailed Description:

- stable financial position with no outstanding court orders;
- the supplier must not be in the process of liquidation, reorganization, or bankruptcy proceedings;
- the supplier's property must not be under seizure;
- the supplier must not be involved in any court or arbitration proceedings;
- recommendation letters and references from organizations are welcome;
- the supplier must provide a guarantee letter for the timely and high-quality performance of work;
- the service provider company must ensure full confidentiality and guarantee the provision of services in full.

6. Technical Requirements

- identify strengths, weaknesses, opportunities, and threats in AI development;

- conduct an analysis of key competitors, and provide recommendations for optimizing Uzbekistan's AI strategies and improving its performance.

2. Develop a Strategic Action Plan:

- propose a detailed roadmap with short-term and long-term measures;

- develop and implement specific strategies aimed at assisting in the provision of quality data on Uzbekistan for underperforming and missing indicators in key international AI rankings;

- benchmarks, KPIs, and expected outcomes.

3. Enhance AI Ecosystem:

- recommend policies to strengthen AI research, talent development, and infrastructure;

- attract international experts and partners, and establish joint research programs;

- identify partnerships with international AI organizations and universities.

4. Promote AI Innovation, Implement Marketing and PR Strategies:

- organize workshops, conferences, and training sessions;

- train government officials, businesses, and academia on AI trends and technologies;

- participation in international AI forums and promotion of Uzbekistan's AI achievements;

- enhance the visibility of Uzbekistan's AI initiatives through international publications, reports, and media.

5. Ensure Compliance and Best Practices:

- follow international standards in AI ethics, data privacy, and security.

6. Provide Regular Reporting:

- submit quarterly and annual progress reports;

- include data analysis, impact assessments, and recommendations for adjustments.
